Sub: Shifting of pending allotments of non-power Linkage Auction rakes of LOCM Grp sidings to Secondary Source i.e. BOCM Grp sidings

This is for the information of all Linkage Auction FSA consumers having LOCM Grp sidings as primary source that due to constraints in production and dispatch from IB Valley area, consumers are allowed to shift their pending allotments to secondary source i.e. BOCM Grp sidings. The modalities of this arrangement are mentioned below:

- As there is no set process of shifting of pending allotments in FOIS, willing consumers need to apply to the undersigned for cancellation of rakes and subsequent re-allocation giving details of such pending allotments for which cancellation is requested.
- Consumers may simultaneously place program in FOIS. However, the endorsement and offer of rail program shall be made on confirmation of cancellation from Railways.
- Fresh allotments shall be taken after sanctioning of rakes by Railways. However, the fresh allotments shall not carry the seniority of the cancelled allotments. The consumers will not have the option of seeking cancellation of such re-allotments.
- Only value paid allotments, in excess of one MSQ equivalent at LOCM Grp siding, are allowed to be shifted under this dispensation.
- Fresh programs of Apr'20 onwards against the Linkage Auction may also be taken at BOCM Grp sidings, provided the consumers maintain one MSQ equivalent of coal value with MCL at any given point of time. Consumers shall have to furnish an Undertaking/Affidavit in this regard.

This facility is optional for the consumers and MCL is not liable for any loss of seniority on any account.
