## नोटिस

Sub: Allocation of 75% of MSQ through Rail mode and 25% through Road mode in Sept'18 for Non-Power consumers taking coal through Rail/MGR mode.

As per the directive received from MoC, GoI and CIL, to ease the availability of rakes to long distance Power Houses depending on Rail mode of transportation and persistently facing critical stock situation, the non power consumers taking coal by Rail mode are hereby advised to take coal to the tune of 25% of MSQ by Road mode and the balance 75% of MSQ quantity through Rail mode for the month of Sept'18. Further considering the availability of coal stock at Hingula OCP in Talcher Coalfields and Kulda OCP & Lakhanpur OCP in IB Coalfields, the non-power consumers taking coal through Rail mode shall be offered 25% of MSQ from any one of these three sources only. However, if any of the Rail borne non power consumers wants to opt for allocation of more than 25% of MSQ by Road mode from any of the above mentioned sources, the same shall also be acceptable. The consumers lifting coal through MGR mode shall have the option to lift maximum quantity of MSQ through MGR and 75% of the balance quantity through Rail mode and rest 25% through Road mode.

Please note that in case of Linkage Auction consumers, change of mode will be guided by the approved provisions communicated by GM (M&S), CIL vide letter no. CIL/M&S/New Pol(47252)/Change of mode/273 dated 05.05.2018. The same notice is available in the websites of CIL/MCL. The scheme is applicable for all non power sector consumers lifting coal through Rail mode irrespective of location of end use plant and distance from MCL mines. It is further to clarify that long distance Rail consumers may take delivery through RCR mode (Road cum Rail through Goods shed or private sidings available). However, in case any rail bound non-power consumer fails to arrange for lifting of 25% of MSQ of Sept'18 through Road mode, the quantity thus short lifted shall be treated as deemed delivered. Therefore all such consumers are requested to arrange for lifting of the earmarked quantity of coal through Road/RCR mode for Sept'18.
