NOTICE

OFFER OF COAL ON 'AS IS WHERE IS BASIS' FOR POWER HOUSES OF CENTRAL/STATE GENCO DRAWING COAL UNDER FSA WITH MCL FOR THE YEAR 2019-20 THROUGH ROAD/ROAD-CUM-RAIL (RCR) MODE .

CIL has communicated the consent for offer of coal in 2019-20 on '*As is Where is Basis*' to Power utilities of Central/State GenCo having FSA with MCL on the same terms and conditions for offer of coal under the scheme, which had been in vogue in previous years with the following directive:

- The scheme of lifting of coal would be on '*As is Where is Basis*' from **the pithead stocks only through Road/RCR mode** by Central/State Power Generating companies having valid FSA with MCL in 2019-20.
- In line with prevailing practice, supply of coal through this scheme would be an integral part of the quantity supplied under FSA and may be availed by both, pre and post 2009 commissioned Power Stations having FSA.
- Under Model FSA for new Power Stations mandatorily lifting coal through Road-cum-Rail Mode to the extent of 10% of ACQ is already provisioned. The '*As is Where is*' scheme would be an additional facility to the willing Power Stations and the quantity so lifted would also be an integral part of the quantity supplied under FSA.

In view of the above, the following collieries are put under the above scheme for 2019-20 as one time offer with the stipulation that power generating companies will have to make their own arrangement for evacuation from the coal stock available at the pithead of the following mines:

All the term and condition of FSA for commercial purpose shall be applicable for coal dispatch under the said scheme. The price applicable under the above scheme shall be as per the FSA including the incentives.

Interested consumers are requested to provide their consent and deposit the coal value within 15th of March, 2020 so that RDO shall be issued with in March' 2020 only.
