## Auction of Coal Linkages under SHAKTI B (iii)

Attention is invited to the letter no. 23011/15/2016-CPD/CLD dated May 22, 2017 issued by the Ministry of Coal, Government of India, to Coal India Limited ("CIL") dealing with matters concerning "Signing of Fuel Supply Agreement (FSA) with Letter of Assurance (LoA) holders of Thermal Power Plants – Fading Away of the existing LoA-FSA Regime and Introduction of a New More Transparent Coal Allocation Policy for Power Sector, 2017 – SHAKTI (Scheme for Harnessing and Allocating Koyala (Coal) Transparently in India)". Paragraph B (iii) of the above letter inter alia envisages that "CIL/SCCL may grant future coal linkages on auction basis for power producers/IPPs without PPAs that are either commissioned or to be commissioned. All such power producers/IPPs may participate in this auction and bid for premium above the notified price of the coal company." In this context, interested entities are requested to start preparations at their end. The detailed time-line and other relevant details/ documents will be published online shortly.
