Notice - For all Consumers regarding issuing Sale Orders for LBL integrated OC

All consumers/ bidders of LBL integrated project (Formerly Lakhanpur OC and Belpahar OC) are hereby informed that the current grade of production at Mines is G12 and G15 grade only. As currently there is no production of G14 grade coal in LBL Integrated OC, hence the sale orders of various schemes that were issued in G14 grade have to be re-issued in G12 grade. The differential amount arising out of difference in grades may be deposited at the earliest to ensure early release of the sale orders.

Similarly, the consumers of NRS Linkage Auction Scheme will be issued Proforma Invoice in the month of April'24 from LBL Integrated OC in G12 and G15 grade, as the case may be for different consumers.
