Notice – Grade Change of Jagannath OCP from G12 to G10

The Grade of Coal of Jagannath OCP has been changed from G12 to G10 with effect from 00:00 hrs of 15-11-2023 (notice copy enclosed).

All the new road sale orders from Jagannath OCP will be issued in G10 grade.

NRS Linkage auction consumers are being sent a revised PI on 20-12-2023 in G-10 grade for their quota of Dec'23. NRS Linkage consumers need to submit acceptance to continue lifting of coal in the revised grade and submit the additional/differential performance security as per MCL notice number MCL/SBP/GM(M&S)/2023/539 Dated 16-12-2023.

A detailed list of running sale orders of different schemes along with their unlifted quantity and differential amount to be paid for lifting remaining quantity in G10 is attached in the annexure. Consumers for these running sale orders can deposit the differential amount and share the details of payment if they intend to lift the unlifted/balance quantity in G10 grade. Once payment is made the details can be mailed to road-sales.mcl@coalindia.in.

Consumer also has the option to lift reduced quantity with available balance if they intend to lift in G10 grade but not willing to make the differential payment. The reduced quantity is also mentioned in the Annexure. Such, consumer can also send a mail to intimate their choice to the mail id mentioned above.
