Sub: Cancellation of pending allotments of non-power rakes (except Linkage Auction) of IB Field sidings and re-allocation from Kanika sidings

This is for the information of all Non-Power FSA consumers of MCL that Kanika siding of MCL has been earmarked for loading of rakes of only non-power consumers since 16th Dec'19. The consumers may opt for cancellation of pending rakes allotted from other sidings of IB Field and subsequently apply for re-indenting from Kanika siding. The modalities of this arrangement are mentioned below:

- Consumers having pending rakes under FSA/MoU (except Linkage Auction) from any of the sidings of IB field other than Kanika, are eligible to avail this facility. The list of such pending rakes are enclosed as Annexure-I.
- Consumers need to apply to the undersigned for cancellation of rakes and subsequent re-allocation giving details of such pending allotments for which cancellation is requested within 7th Jan'2020.
- Consumers may simultaneously place program in FOIS. However, the endorsement and offer of rail program shall be made on confirmation of cancellation from Railways.
- Fresh allotments shall be taken after sanctioning of rakes by Railways. However, the fresh allotments shall not carry the seniority of the cancelled allotments. The consumers will not have the option of seeking cancellation of such re-allotments.
- As there are less pending allotments at Kanika siding, the allotments are expected to be liquidated faster. The consumers are requested to arrange for funds in advance and also maintain advance balance equal to one Monthly Scheduled Quantity (MSQ) at any point of time. If the advance amount falls below that threshold, all the pending rakes of that consumer are liable to be cancelled.
- Coal of Basundhara & Mahalakshmi area of MCL along with purchased coal of Manoharpur Block of OCPL is being loaded onto rakes from Kanika siding, as per availability. The Surface Transportation Charges shall be as applicable for Kanika siding.

This facility is optional for the consumers and MCL is not liable for any loss of seniority on any account.
