#### NOTICE

In reference to MCL's notice no. MCL/SBP/GM (M&S)/2021-22/ 701 dtd 25.02.2022, applications were received from interested consumers for change of mode from Rail to Road mode for June'22 as per CIL guidelines. The list of eligible consumers, along with offered source and applicable premium has been finalised which are enclosed as Annexure-I for needful.

This is further to inform that maximum quantity that can be converted from Rail to Road Mode against applications received in June'22 will not exceed 75% of MSQ for NRS Linkage Auction and exclusive E-Auction consumers. In case of Special Forward e-auction, the maximum quantity can be up to one month's Rail entitlement, subject to other applicable conditions.

In case partial conversion of monthly MSQ is applied against a running Sale Order in Rail mode having pending allotments, advance payment of coal value against such partial quantity has to be deposited for issuance of Road Sales Order. Advance payment lying with MCL shall be refunded/adjusted once all the pending rake allotments are loaded, invoices raised and all claims of the seller are settled. The terms and conditions are also enclosed as Annexure-II.

The eligible consumers agreeing to the terms and conditions, may apply for cancellation of their converted rakes if allotted by Railways and submit application to the office of the undersigned alongwith differential payment if applicable by 30.07.2022, as per the format enclosed as Annexure III for further processing and release of Sales Order in road mode.

It is further clarified that

- For Linkage auction contracts, allocation was done on trigger level basis for each month since Feb'22. Hence, all the pending allotments of any of the month since Feb'22 are eligible for conversion of mode. For pending allotments prior to Feb'22, no. of rakes
  equivalent to 75% of MSQ shall be eligible for mode conversion.
- Minimum of 1 rake shall be eligible against a contract number mentioned in the Annexure-I table, for conversion of mode irrespective of scheme and MSQ.

#### Annexure II

#### **Other Terms and Conditions**

- In case of already allotted rakes, supply by road mode will be considered only after cancellation of allotment by Railways.
- ii) Consumer are advised to submit an Undertaking affirming that:
  - a. There will be no adjustment of quantity on account of supply by Road Mode for lapsed quantity.
  - b. Consumer will not seek conversion of quantity back from Road to Rail.
  - c. The consumer will ensure booking of the quantity and arrange deployment of trucks immediately and no refund of EMD towards any lapsed quantity shall be entertained.
- Consumers are required to submit application for cancellation of allocated rakes for which mode conversion is requested. RDO against cancellation of rakes may be issued after cancellation of allotted rakes and the quantity in Road mode shall be arrived accordingly(E-Auction-4000 tes/FSA- 3894 tes per Rake)
- iv) Maximum of one month's rail entitlement can be converted at a time. As the allocation is presently being done at 75% of MSQ for NRS Linkage Auction consumers, mode conversion up to 75% of MSQ shall be considered against one month's quota. However, if the MSQ is less than one rake then conversion up to one rake is allowed.

As per CIL letter no. CIL/M&S/New Pol/47252/Change of Mode/273 dated 05.05.2018 the dispensation shall be considered for only those willing consumers who have value paid booked orders though Rail mode exceeding one month's schedule quantity.
