**सूचना****Sub: Change of Mode of Supply from Rail to Road by cancellation of previous month indents for Non Power Pre and Post NCDP FSAs of Public Sector Undertakings.**

In view of the huge pendency of arrear rakes, Dispensation of Change of mode from Rail to Road by cancellation of previous month indents has been extended to Non Power Pre and Post NCDP FSAs of Public Sector Undertakings with following terms of Condition.

- Consumer with pendency of Value paid pending order of one Month or more are eligible for change of Mode by cancellation previous indents.
- Arrears of any previous one month entitlement may be requested by consumer for cancellation for change of Mode.
- Consumer will apply on monthly basis for change of mode, Only One month Quantity (Pending Indent) will be consider by MCL for change of Mode in each month subject to conversion of minimum one rake and Amount Tagged in concerned month Sales order will be used for issue Sales Order from Road mode, Differential amount, if Any will be paid by consumer separately.
- The supply of coal in Pre & Post NCDP Non Power FSAs is in notified price. Further, All term of condition stipulated in FSA for despatch coal from Road mode will be applicable for this dispensation of mode change from Rail to Road.
- Road sales section will examine the applications of consumers on month to month basis and issue the RDO after taking clearances from concerned sections. Supply by road mode will be considered only after cancellation of allotment by Railway.
- This dispensation is optional in Nature.
- The supply/allocation of coal is at the discretion of MCL and may be allocated from any source from Road mode.
- Consumer are advised to submit an Undertaking affirming that:
  - a) There will be no adjustment of quantity on account of supply by Road Mode for lapsed quantity.
  - b) Consumer will not seek conversion of quantity back from Road to Rail.

This has been issued with the approval of competent authority.
