Seller on for supply of coal for power generation in terms of the said Agreement.
Now, in terms of aforementioned FSA we hereby state and solemnly affirm as under:

1. That, against the above FSA we furnished long term PPA entered with DISCOMS/
PTCs for MW which is to the extent of % of the generating capacity of the
Plant.
2. That the Power Generated out of the coal received under the FSA from the coal
supplying subsidiary of CIL (name....) during 2014-15 and for the period 1.4.2015
to 30.9.2015 has been supplied to the DISCOM/PTC etc. as per the existing long
term PPA(s) with the DISCOMS/PTC(s).
3. That in case at any stage it is found that the Power Generated out of the coal
supplied under the subject FSA has not been supplied to the DISCOM(s)/PTC(s)
under the long term PPA, We shall be liable for actions as may be available to the
Seller under the FSA considering such failure as 'breach' in terms of the Fuel
Supply agreement and for any other actions taken by any other authority including
the State/Central power regulator.
