NOTICE

Sub: Loading of G11 grade of coal from Platform No-2 of Sardega sidings for Power (IPPs) and Non-Power consumers under FSA

This is for the information of all the consumers (IPPs and Non-Power) having linkages with MCL and lifting coal by Rail mode that the grade of coal being loaded from part of Sardega Siding (MFSJ) siding has been declared as G-11 grade (copy enclosed). The consumers are requested to remit the differential payment towards coal value along with enhanced/differential FC BG/ performance security, as applicable, against their allotted rakes & fresh Allotment.

For Linkage auction NRS consumers willing to take G-11 coal from Sardega Siding, are required to give consent and deposit enhance coal value/ FC-BG/Security Deposit/LC value/ 7 days advance Coal Value as applicable to commence supplies of G-11 grade of coal for allotted rakes and fresh allotment. Failing which no rakes shall be moved from Platform no-2.

For IPPs, the difference in the advance coal value may be remitted against the already allotted rakes if the booking is being done on advance deposit basis. In case of rakes booked under LC mode of payment, the LC value along with 7 days advance coal value as security deposit may be adequately enhanced for G-11 grade of coal. In case of existing Performance Security, the same should be enhanced in compliance to the terms of the FSA.

For CPSE Non-Power customers having FSA under NCDP regime, the differential coal value may be remitted to continue lifting of coal against the allotted rakes for lifting of G-11 grade of coal.

It is requested to submit your consent along with differential payment/ LC/ Performance security/ FC-BG/7 days advance coal value, as applicable.

All others terms of respective FSAs (Power/Non Power) shall be applicable and binding for all commercial purpose.
