### NOTICE

**Subject : Salient Features of the Special e-auction 2015 being launched for the eligible Power Producers (IPP/SEB/CPSU) as per MOC OM 23011/19/2015-CPD dated 30.6.2015 read with the letter No. 23011/19/2015-CPD dated 21.8.2015**

The Special e-auction scheme intends to offer coal to the power-plants which are stressed or in short supply of coal, after taking into account coal supplies received through regular sources like FSA/MOU, coal mined/used from captive coal mines, imports and normal e-auction. The salient features of the scheme are highlighted as under :

1. **Eligibility:** All power producers/plants commissioned or being commissioned in 2015-16 (excluding CPPs).
2. **Price of Coal:** Reserve price of the coal offered shall be (a) CIL notified plus 20% premium for Power Plants having long /medium term PPA with DISCOMs/entities having back-to-back PPA with DISCOMS and (b) CIL notified plus 40% premium for Power Plants having short-term PPA or no PPA.
3. **Eligible Quantity:** The estimated eligible quantity shall be based on the normative coal requirement of the unit after adjusting the coal supplied through regular sources like FSA/MOU, Coal mined/used from captive coal mines and that procured under imports and normal e-auction. The plants under commissioning during 2015-16 may bid for their normative requirement but supply of coal shall be subject to commissioning of the plant.
4. **Application :** Desirous plants shall submit application at CIL Marketing Division providing all required details and documents both in hard copies and soft copies (e-mail address given above and postal address given below) as per the Scheme within the stipulated period of time (which will be notified separately).
5. **Registration :** Eligible plants shall contact the respective Service providers who will be conducting the auction for registration by making requisite payment of registration fees and submitting other required documents.
6. **Bidding and EMD :** Prospective bidders after registration shall be notified about the time and schedule of sources from where the bids shall be conducted. The Bidders shall furnish their e-mail address and make payment of EMD @ Rs.500/- per tonne.
7. **Post e-auction :** Each successful Bidder will be intimated through e-mail / SMS by the Service Provider on the same date after the closure of e-Auction.
8. **Payment of Coal Value :** The successful bidder shall make payment to the concerned coal company within 10 days of the e-auction.

All subsidiary coal companies are advised to place the Scheme along with the salient features in their website for information to the prospective consumers. A pre-bid meeting is


