

**नोटिस / Notice**

**Sub : Dispensation for acceptance of rail programme without deposition of advance coal value for value paid consumers of Non-Power FSA and also for similarly placed consumers of Special Forward/Exclusive e-auction**

All the non-power sector consumers having valid FSA with MCL and the buyers under Special Forward/ Exclusive e-auction are informed that in view of the arrear rakes pending for supplies by rail mode, order booking by rail mode shall be allowed without deposition of advance coal value from the month of May'18 onwards till Mar'19 or further notice, whichever is earlier, subject to the condition that the movement/placement of rakes shall be made only against advance payment. However, this facility shall be provided only to those consumers having value paid arrears of rakes equivalent to at least one month's Monthly Scheduled Quantity (MSQ) in case of FSA consumers or one month's value paid orders in case of booking under Special Forward/Exclusive e-auction.

The consumers are therefore advised to deposit the coal value at least one month in advance from the tentative date of supply of rake and in case of failure to deposit coal value, MCL may cancel the pending allotments without any notice. The consumers willing to avail the facility shall have to submit an undertaking (Annexure-I) in this effect.
