NOTICE

Sub: Conversion of mode of supply from Rail to Road mode for July'23


In reference to MCL's notice no. MCL/SBP/GM (M&S)/2021-22/701 dtd 25.02.2022, applications were received from interested consumers for change of mode from Rail to Road mode for July 2023 as per CIL guidelines vide letter reference no. CIL/M&S/Linkage Auction/02 dated 01.01.2024. The list of eligible consumers, along with offered source and applicable premium has been finalized which are enclosed as Annexure-I. Applicable terms and conditions are also enclosed as Annexure-II.

The eligible consumers agreeing to the terms and conditions may apply for cancellation of their converted rakes if allotted by Railways and submit application to the office of the undersigned alongwith differential payment, if applicable, by **22/01/2024**, as per the format enclosed as Annexure III for further processing and release of Sales Order in road mode.

Moreover, it is informed that

- Quantity equivalent to any one month's pending allotment upto July' 2023 shall be considered for change of mode.
- Minimum of 1 rake shall be eligible against a contract number mentioned in the Annexure-I table, for conversion of mode irrespective of scheme and MSQ.
- The dispensation shall be considered for only those willing consumers who have value paid booked orders though Rail mode exceeding one month's schedule quantity. Consumers must ensure the same.

Annexure II

Other Terms and Conditions

- i. In case of already allotted rakes, supply by road mode will be considered only after cancellation of allotment by Railways
- ii. Consumer are advised to submit an Undertaking affirming that:
 - a) There will be no adjustment of quantity on account of supply by Road Mode for lapsed quantity.
 - b) Consumer will not seek conversion of quantity back from Road to Rail.
 - c) The consumer will ensure booking of the quantity and arrange deployment of trucks immediately and no refund of EMD towards any lapsed quantity shall be entertained.
- iii. Consumers are required to submit application for cancellation of allocated rakes for which mode conversion is requested. RDO against cancellation of rakes may be issued after cancellation of allotted rakes and the quantity in Road mode shall be arrived accordingly (E-Auction-4000 tes/FSA- 3894 tes per rake).
- iv. Quantity equivalent to any one month's pending allotment upto July'23 shall be considered for change of mode subject to conversion of minimum one rake.
- v. In case any difference/deviation is found in any particulars/Winning Premium given in Annexure I, the same shall be levied as per CIL guidelines.

The dispensation shall be considered for only those willing consumers who have value paid booked orders though Rail mode exceeding one month's schedule quantity.
