

NOTICE

Sub : Acceptance of rail programme without advance coal value for non power FSA consumers , having value paid order,

Vide letter no. CIL/M&S/New Pol (47252)/690 dated 25.10.2017, GM(M&S), CIL has communicated that in view of the long pendency of liquidation of arrear rakes, CIL Board in its 348th meeting held on 05.10.17, considered a uniform temporary dispensation for acceptance of Rail programme without any advance payment. The dispensation shall be applicable wherever there is a backlog in supply of coal through Rail mode, under the "ease of doing business" initiatives, for a period of six months to all Non Power FSA Consumers and shall be reviewed thereafter. Board, accorded its approval subject to the following:

1. Non-power FSA consumers having paid the coal value for booking by Rail for MSQ of one month or more against which supply of coal is pending be executed the facility for booking of rakes without advance payment for the subsequent month provided that the Financial Coverage is maintained by the consumer.
2. This would be reviewed at the end of 6 months or till an alternative mechanism is put in place, whichever is earlier.

Consumers are required to submit an undertaking in the form of an affidavit in the enclosed format. This issues with the approval of competent authority.
