CONSENT TO ESTABLISH ORDER

- Consent to Establish was granted to Samleswari OCP of M/s Mahanadi Coalfields Ltd. vide OM no. 2372, dated 10.02.2015 for enhancement of production capacity of Coal from 11.0 MTPA to 15.0 MTPA (over mine lease hold area of 828.76 ha + 99.5 ha. and 49.855 ha, for colony outside the mining lease), At IB Valley Area, P.O. Rampur Colliery, Brajarajnagar of Jharsuguda District.
- 2. Consent to operate of the mine for 15 MTPA coal production over mine lease hold area of 928.264 ha has been granted up to 31.03.2020 vide head office letter no. 3151dt. 28.03.2019.
- The proponent has requested through online application no. 2479694 for increasing the mine lease area from 928.264 ha to 1334.912 Ha only whereas production capacity of the mine (15 MTPA) will remain same.
- The request of the proponent was discussed in the Consent Committee meeting held on 24.07.2019.

In consideration to the request of the proponent and recommendation of the Consent Committee in its meeting held on 24.07.2019, the State Pollution Control Soard, Odisha is pleased for increase in mine lease area from 928 264 ha to 1334 912 ha for production of Coal of capacity 15 MTPA, At - IB valley area, PO - Rampur Colliery, Dist. - Jharsuguda with following conditions.

A. General conditions No. 1 and 10 shall be replaced as follows.

- The proponent shall carry out mining activity as per Environmental Clearance obtained from MoEF&CC, Govt. of India, New Delhi, vide letter no. J-11015/183/2008-IA.II(M), dated 26.12.2019.
- 10. The domestic wastewater generated from the township will be treated in sewage treatment plant. The treated water shall be reused for gardening and plantation and the surplus water if any shall be discharged to outside after meeting the following prescribed standards as notified by the MoEF&CC, Govt. of India vide G.S.R. 1265 (E), dated 13,10,2017.

- B. The following additional conditions are stipulated.
 - 1. Existing wheel washing facility shall be upgraded to mechanized wheel washing system.
 - 2. The proponent shall provide a full fledge ETP for treatment of waste water generated from the mines.
 - 3. De-silting of Lillari nallah shall be done periodically.
 - Dedicated temporary storage facility of used / waste oil etc. shall be provided inside the mining lease area before final disposal.
- C. This order is valid for five years from the date of issue of this order.

All other matter / conditions as given in the Consent to Establish order issued vide OM No. 2372, dated 10.02.2015 shall remain unchanged.
