Sir,

This has reference to your online proposal No. IA/OR/CMIN/272160/2022 dated 11<sup>th</sup> July, 2022 submitted to this Ministry for grant of Environmental Clearance (EC) in terms of the provisions with MoEF & CC's Office Memorandum vide no. F. No. IA3-22/10/2022-IA.III (E 177258) dated 11.04.2022 & 07.05.2022 and as per EIA Notification, 2006) of the Environment Impact Assessment (EIA) Notification, 2006 under the Environment (Protection) Act, 1986 for Expansion of Bhubaneswari opencast coal mining project for increase in production capacity from 28 MTPA to 30 MTPA (increase of 10% w.r.t 20 MTPA) in land area of 638.341 Ha by M/s Mahanadi Coalfields Ltd, located in the village Jilinda, Hensmul (Sharasahi), Hensmul (Talasahi), Naraharipur, Khandualbhal, Kandhal, Madanmohanpur, Langijoda and Anadipur, Tehsil Talcher Sadar, District Angul (Odisha).

2. The proposal was granted EC for production capacity of 20 MTPA in ML area of 808.291 Ha dated 30.11.2012. Further EC was granted for expansion under Clause 7 (ii) of EIA notification, 2006 on 19.02.2014 as per the O.M. dated 19.12.2012 for 25 % expansion i.e. 25 MTPA production capacity in ML area of 638.341 Ha and EC was granted on 16.02.2018 as per O.M. dated 15.09.2017 for 12% expansion (total 40%) i.e. 28 MTPA. Presently the proposal is considered by the Ministry in view of the exigency, as per the provisions of O.M. F. No. IA3-22/10/2022-IA.III dated 07.05.2022.

3. Based on the submission of Project Proponent, Ministry hereby grants approval to Expansion of Bhubaneswari opencast coal mining project for increase in production capacity from 28 MTPA to 30 MTPA (increase of 10% w.r.t 20 MTPA) in land area of 638.341 Ha by M/s Mahanadi Coalfields Ltd, located in the village Jilinda, Hensmul (Sharasahi), Hensmul (Talasahi), Naraharipur, Khandualbhal, Kandhal, Madanmohanpur, Langijoda and Anadipur,

Tehsil Talcher Sadar, District Angul (Odisha) under the provisions of OM vide no. F. No. IA3-22/10/2022-IA.III 07.05.2022, under the Environment Impact Assessment (EIA) Notification, 2006 and subsequent amendments/circulars thereto subject to the compliance of the following terms & conditions / specific conditions for environmental safeguards as stated below:-

- i. PP shall submit Certified Compliance Report of the EC vide No. F. No. No. J-11015/280/2013-IA.II (M) Pt. dated 16<sup>th</sup> February, 2018 granted for total 40% expansion and 2<sup>nd</sup> May, 2022 (amendment in EC), along with EIA/EMP report, prepared based on standard ToRs for the additional capacity of 10% on PARIVESH portal within six months of enhancement of production beyond 40%.
- ii. In view of above (i), Ministry shall ascertain the adequacy of the proposed environmental safeguards and stipulate necessary conditions, if required, which shall be monitored as a part of the EC compliance monitoring.
- iii. PP shall obtain necessary prior consent for enhanced capacity from State Pollution Control Board under Air and Water Act.
- iv. Environmental quality parameters arising out of proposed expansion shall be within the prescribed norms and the same shall be maintained as per prescribed norms.
- v. Hon'ble Supreme Court in an Writ Petition(s) Civil No. 114/2014, Common Cause vs Union of India & Ors vide its judgement dated 8th January, 2020 has directed the Union of India to impose a condition in the mining lease and a similar condition in the environmental clearance and the mining plan to the effect that the mining lease holders shall, after ceasing mining operations, undertake re-grassing the mining area and any other area which may have been disturbed due to their mining activities and restore the land to a condition which is fit for growth of fodder, flora, fauna etc. Compliance of this condition after the mining activity is over at the cost of the mining lease holders/Project Proponent".
- vi. All other terms and conditions as prescribed in Ministry's letter dated 30.11.2012 19.02.2014, 16.02.2018 and 02.05.2022 shall remain the same and need to be complied by PP.
