This has reference to your online proposal No IA/OR/CMIN/88407/2018 dated 13th December, 2018 on the above mentioned subject.

2. The Ministry of Environment, Forest and Climate Change, vide letter dated 28th February, 2018, has granted environmental clearance to the expansion of Lakhanpur Opencast (Phase-II) Coal Mining Project from 18.75 to 21 MTPA in an area of 2452 ha (mine lease area of 2240) for a period of one year, subject to compliance of certain terms and conditions, which *inter-alia* included the following:-

- **4.** The sectoral Expert Appraisal Committee (EAC) in the Ministry for Thermal & Coal Mining Projects in its meeting held on 13-14 December, 2018 has recommended for continuance of the environmental clearance dated 28th February, 2018 to the expansion of Lakhanpur Opencast (Phase-II) Coal Mining project from 18.75 MTPA to 21 MTPA of M/s Mahanadi Coalfields Ltd in area of 2452 ha (mine lease area of 2240) located in District Jharsuguda (Odisha) for a period of one year, subject to the terms and conditions stipulated therein remaining the same.
- 5. Based on recommendations of the EAC, the Ministry of Environment, Forest and Climate Change hereby accords approval for continuance/extension of environmental clearance dated 28th February, 2018 to the expansion of Lakhanpur Opencast (Phase-II) Coal Mining project from 18.75 MTPA to 21 MTPA of M/s Mahanadi Coalfields Ltd in an area of 2452 ha (mine lease area of 2240) located in Tehsil Lakhanpur, District Jharsuguda (Odisha) for a further period of one year, under the provisions of the Environment Impact Assessment Notification, 2006 and subsequent amendments/circulars thereto.
