

This has reference to your online application no. SIA/OR/CMIN/294782/2022 dated 01.12.2022, wherein you have requested for amendment of Environmental Clearance (EC) granted by MoEF & CC. Govt. of India vide letter no./EC identification No. F-J11015/866/2007-IA, II(M) 15th November, 2020 for revalidation of EC and F. No. J-11015/866/2007-IA(M) dated 2nd May, 2022 for amendment of EC issued earlier in favour of M/s. Mahanadi Coalfields Limited.

2. The application was examined in the State Environment Impact Assessment Authority (SEIAA), Odisha in its 105th meeting held on 04.01.2023 in accordance with the EIA Notification, 2006 as amended from time to time and the following points are noted;

- (i) As submitted by the project proponent, it is noted that EC was revalidate for Nadira Underground Coal Mining Project of 0.33 MTPA in ML area 370 Ha of M/s. Mahanadi Coalfield Limited located in village-Jambubahali, Danara, Badajorada and Natedi, Tahasil-Talcher, Dist-Angul (Odisha) for life of mine or a period of 30 years whichever is earlier in favour of M/s. Mahanadi Coalfields Limited vide the above-mentioned EC letter under reference and later amended on 16th September, 2021 and 2nd May 2022.

- (ii) There is an EC conditions in the EC letter dated 15th November, 2020 in point no. 4. (i) in page no. 02 that "Construction of Sewage Treatment Plant (latest technology SBR/MBBR/MBR) should be completed by July 2021 and treated water shall be reused for plantation. As documentary proof, STP photograph after its commission to be submitted to RO, MoEF & CC with copies of its CTE and CTO" and point no. 4. (ii) that "Grant of CTO to the project shall be subject to fulfilment of condition no.1"
- (iii) In the stipulated time period, the project authority has not been able to complete the construction work of STP and now, the PP has requested for amendment in EC for further extension of timeline for another 4 months i.e. till April'23 for completion of the STP.
- (iv) The proposal was placed in the SEAC meeting held on 12.12.2022 and the SEAC recommended the proposal for amendment of EC for further extension of timeline for another 4 months i.e. till April 2023 for completion of the construction of STP
3. **Amendment of Environmental Clearance (EC) of Nadira Underground Coal Mining Project of 0.33 MTPA in ML area 370 Ha of M/s. Mahanadi Coalfield Limited located in village-Jambubahali, Danara, Badajorada and Natedi, Tahasil-Talcher, Dist-Angul (Odisha) issued by MoEF & CC, Govt. of India vide EC letter/EC identification no./EC identification no. vide letter no. F. No. J-11015/866/2007-IA(M) dated 2nd May, 2022 is allowed for amendment on point no. 4. (i) & (ii) for further extension of timeline for another 4 months i.e. till April 2023 for completion of the construction of STP. The other stipulated terms and conditions of the original EC initially granted remains same subject to satisfactory compliance to all the stipulated terms and conditions of EC.**
