Earlier, the modification in the standard NITs for Vehicle Hiring Contract of E&M Deptt. (having estimated cost less than Rs 1.00 Cr) regarding modification in standard estimate format for hiring of vehicle of E&M Deptt. has been circulated vide the above referred letter at sl. no. (i).

Recently, there is amendment in e-Procurement Process of CIL for Works & Services and accordingly Guidelines for e-Procurement of Works and Services of CIL (Updated till March 2020) has been circulated by CIL. Subsequently, a letter as referred at sl. no. (iv) above has been issued by this office for immediate stoppage of floating new tenders for works contract & vehicle hiring contract of E&M Deptt., MCL.

Now, the following standard NITs for vehicle hiring contract of E&M Deptt., MCL have been prepared in line with the Guidelines for e-Procurement of Works and Services of CIL (Updated till March 2020) and some changes related to UDIN, Reimbursement of CMPS, Pre-Contract Integrity Pact, Attendance of contractor workers through AEBAS portal, registration of contractors on CLPMP portal of CIL, age norm of vehicles and GST. Accordingly, the new GTE (VEHICLE_HIRING_LPV_OTHER_THAN_LPV_30_04_20) have been created in the e-Procurement Portal of CIL for hiring of both (i) Light Passenger Vehicle/Covered Jeep and (ii) other than Light Passenger Vehicle/Covered Jeep, which is compatible with these NITs. Further, new BOQ has been prepared as per the change in GST rule which is compatible with these NITs. The type of hiring of vehicle and the NIT to be used is detailed below.
