Dear Sir,

The above mentioned contract has been awarded to you vide GEMC-511687785953986 dated. 11.08.2023 for the deployment of vehicles at Garjanbahal OCP, Basundhara Area. You haven't submitted the Performance Security Deposit (PSD) within the stipulated time of 15 days from the date of generation of contract. So an Incident vide no. 1690840 dated. 31.08.2023 was raised against you. You have neither replied to the incident nor submitted the PSD. So on dtd. 08.09.2023, the incident was escalated to GeM authorities for further action against you as per GeM terms and conditions. A show cause notice was sent by the system admin to you on dated. 08.09.2023 and later due to lack of response from you, system admin has suspended your account from 19.09.2023 to 03.11.2023. As per the principle of natural justice towards debarment of any business entity, a Show Cause Notice vide no. MCL/GM/BA/E&M/2023-24/672 dated. 23.09.2023 has been issued to you. Show Cause Notice period was expired on 09.10.2023. You haven't replied to the Show Cause Notice within 15 days of issue of the aforesaid notice.

As per "Buyer Added Bid Specific Terms and Conditions" clause no.: 9:-

After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter.

In view of the above and as per above mentioned clauses, following penal actions are hereby imposed on you:

1. Termination of the contract.
2. You will be debarred from participating in future tenders of MCL for a period of 1 year.
