Dear Sir,

The contract for deployment of one no. of Bolero for Basundhara Area, was awarded to you vide contract no. GEMC-511687776180832 dated. 24.01.2024. You have not submitted the Performance Security Deposit (PSD) within the stipulated time of 15 days from the date of generation of the contract as per Terms and Conditions part of bid document. So, an incident vide no. 1810976 was raised against you on dated. 09.02.2024. You have neither replied to the incident nor submitted the Performance Security Deposit. So the incident was escalated to GeM authorities and a show cause notice was issued to you for further action as per GeM T&C. GeM system admin took action on you and had suspended your account from dated. 01.03.2024 to 31.03.2024.

With the approval of the competent authority at area level the aforesaid contract was terminated. Along with the termination of contract;

As per "Buyer Added Bid Specific Terms and Conditions" clause no.: 9:-

"After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter."

In view of the above and as per above mentioned clause, following penal actions are hereby imposed on you:

1. Termination of the contract placed vide GEMC-511687776180832 dated. 24.01.2024.
2. Debarment from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD No.: FD/MCL/SBP/2024-25/REV/D-96/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 01 YEAR/BASUNDHARA AREA/Dt.10.05.2024.
