Dear Sir,

The contract for deployment of two nos. of Fog Cannons for Basundhara Area, was awarded to you vide contract order no. GEMC-511687727704811 dated. 20.04.2024. You have not submitted the Performance Security Deposit (PSD) within the stipulated time of 15 days from the date of generation of the contract as per Terms and Conditions part of bid document. So, an incident vide no. 1880224 was raised against you on dated. 06.05.2024. You have not submitted the Performance Security Deposit even after several reminders. So the incident was escalated to GeM authorities and a show cause notice was issued to you for further action as per GeM T&C. GeM system admin took action on you and had suspended your account from dated. 25.05.2024 to 24.06.2024.

With the approval of the competent authority at area level the aforesaid contract was terminated. Along with the termination of contract;

As per "Buyer Added Bid Specific Additional Terms and Conditions" clause no.: 20:-

Performance Security Deposit (PSD) must be submitted by the contractor within 15 days of issuance of Contract generated through GeM. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall ban such defaulting contractor from participating in future tenders of MCL for a minimum period of minimum one year from the date of issue of such letter. In case of Partnership firm, the banning shall also be applicable to all individual partners of Partnership firm.

1. Termination of the contract placed vide GEMC-511687727704811 dated. 20.04.2024.
2. Debarment from participating in future tenders of MCL for a period of one year from the date of issue of this letter; approved vide FD No.: FD/MCL/SBP/2024-25/REV/D-259/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 01 YEAR/Dt.03.07.2024.
