Dear Sir,

The above mentioned contract has been awarded to you vide GEMC-511687713307544 dated. 28.03.2023 for the deployment of vehicle at Kulda OCP, Basundhara Area. The contract was placed in GeM portal on dated. 28.03.2023. As per Bid Terms & Conditions clause no. 9; you are supposed to submit the Performance Security Deposit within 15 days of award of contract; which you have failed to do so. So, an incident vide no. 1602377 was raised against you in GeM Portal on dated. 17.04.2023. Even then, you have failed to submit the performance security deposit for the above mentioned contract. You have replied to the incident and have denied to provide the service. Then the incident was escalated to GeM authorities for further action against the bidder as per GeM terms & conditions.

As per "Buyer Added Bid Specific Terms and Conditions" clause no.: 9:-

After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter.

The bidder didn't submit the Performance Security Deposit within 15 days of award of work; as per the above clause, the following penal actions are taken against the bidder:

In view of the above and as per above mentioned clause, following penal actions are hereby imposed on you:

1. Termination of the contract.
2. Debarment of the bidder from participating in future tenders of MCL for a period of one year.
