**Sub: Cancellation of contract & Debarment from participating in future tenders of MCL for a period of one year.**

Dear Sir,

With reference to the above GeM Contract, you were awarded the service contract "Hiring of Bolero or equivalent covered vehicle having seating 6+1 more with AC fitted (Diesel) with 12 hrs duty, maximum 3000km run per month for 682 days in 02 years for Personnel Department of Bharatpur Area"

As per point no.7 & 8 of Clause no. 2.7 of Buyer Added Bid Specific ATC:

**QUOTE:**

*"Clause no.7: After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter."*

*"Clause no.8: If the contractor, without reasonable cause or valid reasons, commits default in commencing the work within the aforesaid time limit or fail to execute the work satisfactorily, the company shall, without prejudice to any other right or remedy, be at liberty, by giving 15 days' notice in writing to the contractor to commence the work, failing which to forfeit the Earnest Money, deposited by him and to rescind the Contract document generated on GeM/Work Order and also to debar the contractor to take part in the future re-tender. The Company may debar such defaulting Contractors from participating in future Tenders for a minimum period of 1 (One) year in MCL."*

Thus, you had to submit the Performance Security in the form of FDR/DD within 15 days of award of contract i.e. latest by 15.02.2024. But you did not deposit the PSD. Also, as per the GeM Contract, you have to deploy vehicle from 29.02.2024. But, you have not provided any vehicle till date and in reply of our email/ GeM Incident-1836874, you have replied on 06.03.2024 that due to some financial crisis you are unable to deploy any vehicle.

In view of above, the following penal actions are hereby imposed on you as per as per point no.7 & 8 of Clause no. 2.7 of Buyer Added Bid Specific ATC (Buyer Added Bid Specific ATC) of the GeM Contract:

1. Cancellation of GeM Contract No. GEMC-511687771121008 Dtd. 26.02.2024.
2. Debarment of RABINDRA KUMAR ROUT from participating in future tenders of MCL for a period of one year from the date of issue of this letter.
