With reference to the above GeM Contract, you were awarded the service contract "Hiring of 04 nos. of mini trucks mounted lighting tower with light fittings and DG Set (Composite system) comprising of one suitable capacity mini truck chassis with one no. 7 m long telescopic /tilting type lighting tower system fitted with 08 nos. 400W LED flood lights and one no. 7.5KVA DG Set each for Bharatpur OCP"

As per GeM ATC Clause no. 4.2 of **General Terms & Conditions**, which reads as:

#### **Clause no. 4.2 of General Terms & Conditions:**

- PBG should be 5% of contract amount and should be submitted within **15 days of issuance of Contract generated through GeM** by the successful bidder, as per the GeM format.
- The PBG (s) shall remain valid till 2 Months beyond the contract period.
- Copy of PBG along with SFMS confirmation should be uploaded in GeM and send to the Concerned Department of Bharatpur Area of Mahanadi Coalfields Limited at GM Office, Bharatpur Area, Distt:Angul, Odisha (PIN:759148) by Speed Post/ Registered Post (AD).
- The Earnest Money/ Bid Security shall be discharged when the Bidder has furnished the required Performance Security/ 1st part of security deposit.
- In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security/ earnest money.

Additionally, the company shall ban such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter.

You had to submit the Performance Security in the form of FDR/DD within 15 days of award of contract i.e. latest by 27.03.2024. But you did not deposit the PSD. Also, as per the GeM Contract, you have to deploy vehicle from 01.04.2024. But, you have not provided any vehicle till date. Thus, failure of submission of Performance Security Deposit holds sufficient grounds for immediate Termination of Contract along with debarment of contractor from participating in future tenders of MCL for a period of one year.

In view of above, the following penal actions are hereby imposed on you as per ATC Clause no. 4.2 of General Terms & Conditions of Buyer Added Bid Specific ATC of the GeM Contract:

1. Cancellation of GeM Contract No. GEMC- 511687760539826 Dt. 12.03.2024.
2. Debarment of M/s Jagannath Traders, from participating in future tenders of MCL for a period of one year from the date of issue of this letter.
