Dear Sir,

A GeM contract has been awarded to you vide contract no. GEMC-511687794026322 dated 03.01.2023 (pg.no.71) for the service" monthly basis cab & Taxi Hiring services for the service mentioned in subject. Service work order the service is MCL/GM/CWST/SO(E&M)/WO/Scoprio-GM/2022-23/36 dtd.02.02.2023 and the contract start date and end date are 05.01.2023 to 04.01.2025 respectively as per the GeM contract. You have deployed the vehicle from 05.01.2023 and as well as deposited the performance security in the form of FDR vide no. 41613029474 for an amount of ₹45,000.00 and issue dated on 24.01.2023 as per the terms and conditions of GeM contract.

Information received from the controlling officer (Area General Manager) of the vehicle vide letter no. MCL/GM/CWST/Vehicle/2023-24/26 dtd. 02.07.2023 and MCL/GM/CWST/Vehicle/2024-25/009 dtd. 03.05.2024 relating to non-deployment of the vehicle and poor service provided by you. Accordingly, emails have been sent to you for non-deployment of the vehicle on dtd. 03.07.2023,04.05.2024, 16.05.2024 and 18.05.2024 respectively. Moreover, the controlling officer has warned you about the frequent breakdowns and maintaining insufficient fuel in the vehicle. In spite of that, you did not improve the service performance as per the GeM contract terms and conditions.

A show cause notice vide no. MCL/GM/CWST/SO(E&M)/2024-25/017 dtd. 30.05.2024 issued to you by the staff officer(E&M), CWS(X) Talcher MCL for non-deployment of the vehicle. However, no show cause reply was received within the suitable time as mentioned in the show cause letter. Thus, it has been presumed that no reply was received to the show cause notice and further action initiated as per the as per clauses mentioned in the GeM contract.

As per clause 8, clause no. 14 and 47(C) of buyer added bid specific ATC of the GeM contract that the buyer has a liberty to levy penalty and terminate the contract as per the defaults i.e. "non deployment of vehicle (no replacement provide)" and three instances have already been over and informed to you.

Therefore, in view of the above mentioned clauses, the following penal actions are hereby imposed on you as per the terms and conditions of the GeM contract.

1. Termination of the GeM contract.
2. Forfeiture of PSD amount to Rs. 45,000.00 (vide FDR vide no. 41613029474, SBI MCL Jagannath Colliery). In addition to PSD forfeiture, a penalty of Rs. 5571.00 is to be deducted from the bills of M/s. SAI UDAY TRAVELS as and when raise the bills.
3. You will be debarred from participating in future bidding in MCL for a period of 1 year (12 months).

This issues with the approval of competent authority.
