Dear Sir,

With reference to the above you were awarded a GeM Contract for the work "Hiring of two (02) Nos. of Diesel Jeep (Bolero) or equivalent covered vehicle for 12 hours non shift duty (3000km/month) (with 02 days rest for month) (each vehicle) for a period of three (03) years (with 02 days rest per month) for deployment at Hingula OCP, Hingula Area."

As per clause no. 8 of Buyer Added Bid Specific ATC

Quote:

"After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from the date of issue of such letter."

You had to submit the performance security in the form of FDR/DD within 15 days of award of contract, but you have not done so. Accordingly, you were issued a show cause notice; however, no response was received from your end.

In view of the above the following penal actions as per Clause No. 8 of Buyer Added Bid Specific ATC of GeM Contract are imposed on you.

- 2) Raising of incident on GeM portal.
- 3) Debarment from participating in future tenders of MCL for a period of one (1) year from the date of issue of this letter.
