With reference to the above you were awarded the above mentioned GeM Contract for the work "Hiring of one (01) No. of Diesel Jeep (Bolero) or equivalent covered vehicle for 24 hours non-shift duty for a period of two (02) months (with 02 days rest per month) for deployment at Hingula OCP, Hingula Area."
