Dear Sir,

With reference to the above you were awarded a GeM Contract for the work "Hiring of one (01) No. of Diesel Jeep (Bolero) or equivalent vehicle for 24 hours (4000km/month) shift duty for a period of two (02) years (with 02 days rest per month) for deployment at Balram OCP, Hingula Area."

As per clause no. 8 of Buyer Added Bid Specific ATC

**Quote:**

**"After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from the date of issue of such letter."**

You had to submit the performance security in the form of FDR/DD within 15 days of award of contract, but you have not done so. Accordingly you were issued a show cause notice; however, no response was received from your end.
