Dear Sir,

With reference to GEM portal Bid no: GEM/2024/B/4438654 and GEM order no: GEMC-511687744426578 dated:23.02.2024, you had participated in the above tender and you had been awarded the order for execution of the hiring service of school bus. You have not submitted the PSD amount. You have been sent a mail on dated: 11.03.2024 regarding submission of PSD amount, the response of which has not been received till dated. After obtaining competent approval, the above mentioned GEM order has been cancelled and the subject work has been retendered. This has caused loss of resources and time for the company. Accordingly, an incident has been raised in GEM portal vide no: 1866767 against your firm.

You have also been issued a showcause letter vide no: MCL/IBV/E&M/24-25/265 dated: 06.05.2024 against which no response has been obtained. In view of this, the tender inviting authority has recommended the debarring of your firm for a period of one year from participating in future tenders in MCL which has been approved by Competent authority from MCL HQ as it is in line with Bid clause no. 11.8 of the Buyer added bid specific terms and conditions. **Your firm by the name Maa Budhi Travels stands debarred/banned from participating in the tenders of MCL for a period of 01 year from the date of issue of this letter.**
