With reference to the above GeM Contract, you were awarded the GeM contract of "**Hiring of 05 nos. Mini truck mounted Lighting Tower with Light Fittings and DG Set (composite system) comprising of Mini Truck with one nos. 7m long telescopic tiltable Lighting Tower System fitted with 08 nos. of 400W LED Flood Lights and one nos. of 7.5kVA DG Set for Ananta OCP, Jagannath Area for a period of two years**"

As per Clause No. 20 of the Bid Specific ATC,

QUOTE

Performance Security Deposit (PSD) must be submitted by the contractor within 15 days of issuance of Contract generated through GeM. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall ban such defaulting contractor from participating in future tenders of MCL for a minimum period of minimum one year from the date of issue of such letter. In case of Partnership firm, the banning shall also be applicable to all individual partners of Partnership firm.

The Performance Security was to be submitted by you within 15 (Fifteen) days of issuance of Contract generated through GeM. But the Performance Security has not been deposited within the stipulated date. Hence, on Showcause Letter was issued to you vide no. 380 dtd. 18/03/2024 through your registered mail id and by speed post. However, no reply has been received to this office. Subsequently, an incident was raised on GeM vide no. 1851769 on Dt. 20.03.2024 and sub-sequently it has been escalated on GeM portal.

In view of the above, following penal actions are being imposed on you as per Clause No. 20 of the Bid Specific ATC:

- (1) Banning of your firm M/S JAGANNATH TRADERS, PROP: SONALI SAHU, GST No. 21KOXPS9115F1ZB, from participation in future tenders of MCL for a period of one year from the date of issuance of this letter.
