Dear Sir,

With reference to the above GeM Contract, you were awarded the service contract "Hiring of one no. SUV (Bolero or equivalent covered vehicle having seating capacity 6 plus 1) on 12 hours duty (one driver with staggered rest), max run 2842 km/month for 682 days in a period of Two years for use at Jagannath OCP, Jagannath Area."

As per point no.7 of Clause no. 2.11 of Buyer Added Bid Specific ATC,


QUOTE:

"After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter."

Hence, you had to submit the Performance Security in the form of FDR/DD within 15 days of award of contract i.e. latest by 12.05.2023. But you did not deposit the PSD. Accordingly, incidents were raised on GeM vide no. 1612336 on Dt. 16.05.2023 and escalated on 24.05.2023.

In view of above, the following penal actions are hereby imposed on you as per sl. no. 7 of Clause no.2.11 (Buyer Added Bid Specific ATC) of the GeM Contract:


