महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no., a tender has been floated for hiring of vehicle (Bolero or equivalent) for Area Safety department and Regional/Central Store Belpahar(RCSB), Lakhanpur Area, MCL. The bid was opened on 27.11.2023 and Jagannath Pradhan was found to be the Techno-commercially established L1 bidder. A letter was received (received no.:147, dtd:18.12.2023) stating that "I, Jagannath Pradhan, Proprietor of M/S. Jagannath Pradhan, hereby declare that i am not able to provide vehicle in bid no.: GEM/2023/B/4223769, due to some personal issue. You had withdrawn your bid due to which finalization of tender is delayed . Accordingly, an incident vide no: 1798333 has been raised in GeM portal against your firm. As per clause no.: 11(6) of Buyer Added Bid Specific ATC of GeM Bid which is as follows:

**"If L1 bidder backs out (i.e. Techno commercially established L1 bidder), the EMD will be forfeited and the bidder will be debarred for minimum one (1) year from participating in tenders in MCL".**


According to the above clauses, you are not eligible for award of contract.

The above act of your firm Jagannath Pradhan, of participation in the tendering process and withdrawing the bid attracts action against clause no. 11(6) of Bid Specific ATC for GeM Bid. In view of the above, following penal action are hereby imposed on you as per clause no. 11(6) of Buyer Added Bid Specific ATC of GeM Bid:

1. **Debarring from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.: FD/MCL/SBP/2023-24/REV/D-930/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 1 YEAR/LAKHANPUR AREA/Dt.06.03.2024.**
