महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no. and Contract ref. no., a contract for hiring of vehicle (Bolero or equivalent) for E&M Department, ILBL, MCL has been placed on you. You had withdrawn the vehicle from duty due to some medical emergency & financial condition and was not able to continue the services from 25.06.2024 onwards. Now, as per Clause no.(46(C)) Buyer added bid specific ATC of GeM Contract, which are as follows:

Clause no.(46(C))- "On cancellation of the contract or on termination of the contract, the Engineer-in-charge shall have powers:

The contractor whose contract is terminated shall not be allowed to participate in future bidding in MCL for period of minimum twelve months. In such an event, the contractor shall be liable for loss/damage suffered by the employer because of action under this clause and to compensate for this loss or damage, the employer shall be entitled to recover higher of the following:

i) Forfeiture of security deposit at disposal of the employer.

Or

ii) 10% of value of incomplete work. The value of the incomplete work shall be calculated for the items and quantities remaining incomplete (as per provision of contract) at the contract rates including price variation as applicable on the date, when notice in writing for termination of work was issued to the contractor."

The contract has been terminated and penal action was imposed as per above mentioned clause vide termination letter no.473 dtd:30.09.2024. As per above clause "The contractor whose contract is terminated shall not be allowed to participate in future bidding in MCL for period of minimum twelve months". In view of the above, following penal action are hereby imposed on you as per Clause no.(46(C)) of Buyer added Bid Specific ATC in GeM Contract:


1. **Debarring from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.: FD/MCL/SBP/2024-25/REV/D-566/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 12 MONTHS/LAKHANPUR AREA/Dt.26.10.2024..**
