महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no., a tender has been floated for hiring of vehicle (Road Sweeper) for Lakhanpur Area, MCL. While participating in GeM, bidder undertakes that presently it is not debarred from bidding mentioned in Rule 151 of GFR 2017 and the same was asked by you to submit in the given format as per Annexure-IV. But you had not declared about banning from Coal India Tender Portal for a period of 02 years (03.05.2021- 02.05.2023). As per clause no.:14(2)(vi)-(5) which is as:

14. Guidelines for Banning of Business:

CIL and its Subsidiary Companies shall follow the following guidelines for effecting 'Banning of Business' with a contracting entity in respect of Works and Services Contracts.

- The contracting entity may be banned in the following circumstances: -
vi) Willful suppression of facts or furnishing or wrong information or manipulated or forged documents by the Agency or using any other illegal/unfair means.
- Such 'Banning of Business', if and when effected, shall be with prospective effect only. The effect of 'Banning of Business' shall be for future tenders from the date of issue of such Order. However, if any contracting entity is banned after online notification of opening of Price Bid, such a ban will not be effective for that work.
- The banning shall be for a **minimum period of one year** and shall be effective for the concerned Subsidiary for the tenders invited at Subsidiary level.
- Once a contracting entity is banned, it shall be extended to the constituents of that entity, all the partners in case of Partnership Firm, owner/proprietor in case of Proprietorship Firm and all the Directors in case of Limited Company. If such banned owner/Proprietor/ Partner/Director make/form different Firms/entity and attempts to participate in tenders, the same will not be entertained during the currency of such banning.
- The above 'Banning of Business' shall be in addition to other penal provisions of GeM Bid/Contract document.

According to the above clauses, you are not eligible for award of contract.



The above act of your firm S.N.S. Industrial Works Private Limited, of participation in the tendering process by submitting wrong undertaking attracts action against Sr. no. (vi) of clause no. 14.2 of Bid
