महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no., a tender has been floated and subsequently awarded for "Hiing of 1 No. Truck mounted Mechanical Road Sweeper for Lakhanpur Area". The vehicle deployment start date was 06.09.2023 as per GeM Contract and upto 21.10.2023(As per clause no.- 2.6(2) of Buyer Added Bid Specific ATC). Now, as per Clause no.4.2(a) of General Terms And Conditions of GeM Contract, the successful bidder has to submit Performance security within 15 days of award of Contract and also has to upload scanned copy of same on GeM portal, but you have not submitted Performance Security within 15 days i.e till 06.09.23 and also not uploaded scanned copy on GeM portal within 15 days. Accordingly, an incident vide no: 1716690 has been raised in GeM portal against your firm. Moreover, as per 4.2(e) of General Terms And Conditions of GeM contract, which is as follows:

**Clause 4.2(a)-** " PBG should be 3% of contract amount and should be submitted within 15 days of issuance of Contract generated through GeM by the successful bidder, as per the GeM format."

**Clause 4.2(e)-** " In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security/ earnest money.

Additionally, the company shall ban such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter.

In case of Partnership firm, the banning shall also be applicable to all individual partners of Partnership firm."

According to the above clauses, you are not eligible for award of contract.

The above act by the contractor M/S VED PRAKASH, of not submitting Performance Security within 15 days i.e till 06.09.2023 and also not uploading scanned copy on GeM portal within 15 days attracts action against Clause no.4.2(e) of General Terms And Conditions of GeM contract. In view of the above, following penal action are hereby imposed on you as per clause no. 4.2(c) of General Terms And Conditions of GeM contract:

- 1. Debarring from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.: FD/MCL/SBP/2023-24/REV/D-563/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 1 YEAR/LAKHANPUR AREA/Dt.07.11.2023.**
