महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no and contract no., a tender has been awarded for hiring of vehicle (Scorpio Classic S or equivalent) for BOCM, Lakhanpur Area, MCL. The vehicle deployment start date was 20.12.2023 as per GeM Contract. Now, as per Clause no.2.9 and 2.10 of GeM Contract, successful bidder has to submit Performance security in the form of FDR/Demand Draft(besides PBG) within 15 days of award of Contract and also has to upload scanned copy of same on GeM portal, but you had not submitted Performance Security and also not uploaded scanned copy on GeM portal within 15 days i.e till 20.12.2023. An e-mail has been sent by you dtd:19.12.2023 stating that "I am writing this email with reference to GEMC-511687793357996 With utmost regret I would like to inform you that the company is facing a severe financial crisis currently resulting in certain operational fallacies. Thus we would need an additional time frame to deploy the vehicle as per contract as we are not at all in a financial stability to deploy the vehicle. We humbly request you to provide an additional time of 4 months to deploy the vehicle. However we will try our best to deploy the vehicle as soon as possible but it seems absolutely difficult in a situation like this." Accordingly, an incident vide no: 1794752 has been raised in GeM portal against your firm Moreover, as per Clause no.8 of Buyer Added bid specific ATC of GeM contract, which is as follows:

**"After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter."**

According to the above clauses, you are not eligible for award of contract.

The above act of your firm Z2 Plus Placement & Security Agency Private Limited, of not submitting Performance Security on time attracts action against clause no. 8 of Buyer Added bid specific ATC of GeM contract. In view of the above, following penal action are hereby imposed on you as per clause no.8 of Buyer Added bid specific ATC of GeM contract:

1. Termination of GeM Contract ref. No.: - GEMC-511687793357996, Dtd- 05-Dec-2023.
2. Debarring from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.: FD/MCL/SBP/2023-24/REV/D-920/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 1 YEAR/LAKHANPUR AREA/Dt.02.03.2024.
