महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no., a tender has been floated for hiring of vehicle (Pick-up Van) for Lakhanpur OCP, MCL. The rate quoted by you was abnormally low i.e 82.16% below the estimated cost and 82.16% below the updated cost. A letter was sent vide ref. no.MCL/GM/LKPA/SO(E&M)/24-25/06 dtd. 02.04.2024 through e-mail and by post also to you regarding rate justification. You had responded through email and stated that "We are apology for this requesting you please disqualify us." You had withdrawn your bid due to which finalization of tender is delayed. Accordingly, an incident vide no: 1870469 has been raised in GeM portal against your firm. As per clause no.: 11(7) of Buyer Added Bid Specific ATC of GeM Bid which is as follows:

"If L1 bidder backs out (i.e. Techno commercially established L1 bidder), the EMD will be forfeited and the bidder will be debarred for minimum one (1) year from participating in tenders in MCL".

According to the above clauses, you are not eligible for award of contract.

The above act of your firm RRR And Associates, of participation in the tendering process and withdrawing the bid attracts action against clause no. 11(7) of Bid Specific ATC for GeM Bid. In view of the above, following penal action are hereby imposed on you as per clause no. 11(7) of Buyer added Bid Specific ATC in GeM Contract:

1. Debarring from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.: FD/MCL/SBP/2024-25/REV/D-133/APPROVAL FOR BANNING OF BIDDER FOR A PERIOD OF 1 YEAR/LAKHANPUR AREA/Dt.21.05.2024.
