महोदय/ Dear Sir,

With reference to above mentioned GeM Bid no. and Contract ref. no., a contract for hiring of vehicle (Shift Bus) for ILBL OCP, Lakhanpur Area, MCL has been placed. You had not submitted Performance Security within 15 days i.e till 27.12.2024 and also not uploaded scanned copy on GeM portal within 15 days. Accordingly, an incident vide no: 2080196 has been raised in GeM portal against your firm. Moreover, as per Clause no.8 of Buyer Added bid specific ATC of GeM contract, which is as follows:

“After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter.”

The contract has been terminated and penal action was imposed as per above mentioned clause vide termination letter no.729 dtd:29.01.2025. As per above clause *“the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter”*. In view of the above, following penal action are hereby imposed on you as per Clause no.8 of Buyer added Bid Specific ATC in GeM Contract:

1. **Debarring from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.: FD No:-FD/MCL/SBP/2024-25/REV/D-897/APPROVAL FOR BANNING OF CONTRACTOR FOR A PERIOD OF 1 YEAR/Dt.10.03.2025.**
