Dear Sir/Madam,

With reference to the above, you were awarded the GeM contract for service “Hiring of 02 Nos. of Diesel covered Bolero or equivalent, minimum 7-seater with AC fitted, Daily 24 hours operation for a period of 03 years (341 working days per year) for PO Office Pool, Lingaraj OCP with monthly limit within 3410 kms”. You had to submit the Performance security within 15 days of the award of the contract as per GeM Buyer added Bid specific ATC. A mail and further reminder regarding submission of PSD on above mentioned correspondence email id has also been sent to you but you have not submitted the Performance security within the stipulated time.

The date of contract generation was 12.02.2025 and the last date of submission of Performance security deposit was 27.02.2025.

As per clause no.08 of GeM Buyer Added Bid Specific ATC

Quote

After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter.

A show cause notice was also issued to you vide letter No. GM(LA)/SO(E&M)/Letter/2024-25/654 Dtd. 04.03.2025. But you did not respond to the show cause notice also.

The letter regarding cancellation of contract has already been issued vide no.701 dtd.22.03.2025.



In view of the above, the following penal actions are hereby imposed on Sabita Upadhyay for non-submission of Performance security as per clause 8 of Buyer Added Bid Specific ATC of GeM bid document.

1. Banning of the firm Sabita Upadhyay from participating in future tenders of MCL for a period of one year from the date of issue of this letter.
