With reference to your participation in referred bid and evaluations, you have been awarded GEM contract. You have been informed regarding submission of PSD within 15 days of award of GEM contract i.e. within dtd. 14/06/2024 via email dtd. 30/05/24 and reminder email dtd. 07/06/2024. Since you failed to submit the Performance Security within due time, show cause notice was issued to you vide referred letter dtd. 17/06/2024 giving time upto dtd. 24/06/2024 for observance of principle of natural justice, but you have failed to submit your response within stipulated time.

Since you have failed to submit the performance security, following penal action is being imposed on you as per clause no. 5 of "other terms and conditions" of ATC attached under clause no. 2.10 of buyer added bid specific terms and conditions of referred GEM contract:

- 1) Cancellation of GEM contract and forfeiture of bid security (EMD exemption claimed by the party by submitting MSE certificate, hence bid security forfeiture is not applicable).
- 2) Debarring/Banning of your business from participating in future tenders of MCL for a period of 01(one) year from the date of issue of this letter.
