Sub: Rescission of GEM contract & Debarment from participating in future tenders of MCL for a period of one year.

Dear Sir,

With reference to the above GeM contract, you were awarded the service contract for "Hiring of One(01) No. of Swift Dzire or its equivalent car with AC fitted(Petrol) having seating capacity of 5 (4+1) for a period of Two years (i.e. 682 Days) @ 12Hrs/Day, maximum run of 2800 Km/month(100Km/Day) engagement at Pool of Finance Department, Talcher Area." Accordingly you had commenced the work and deployed the vehicle from 04.12.2023. But on dtd.16.02.2024 a letter was received from your end regarding your inability to provide the vehicle in which you had mentioned that the vehicle was deployed from 04.12.2023 to 14.02.2024 but stopped providing the vehicle from 15.02.2024 due to heavy financial loss incurred and had requested to terminate the contract. A reply vide no.554 dtd.02.03.2024 to your letter was given to you in which it was mentioned that the above act of your firm is a violation of terms and conditions of GEM contract and you will be liable for the penal actions mentioned in reply letter apart from other penal action prescribed elsewhere in the terms and conditions of GEM Contract.

Again on 05.04.2024, a notice was given to you stating penal actions in which it was advised to submit your reply in writing to the undersigned within 15 (Fifteen) calendar days from the date of issue of the notice as to why penal action shall not be taken against your firm i.e. BRIJ KISHORE SINGH. But you didn't reply.

Accordingly incident has been raised on GeM portal vide no.1884057. However, since you have availed exemption from EMD being MSE during bid submission, forfeiture of bid security/earnest money is not applicable.

3. Debarment of **BRIJ KISHORE SINGH** from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD no.:FD/MCL/SBP/2024-25/REV/D-82/APPROVAL FOR DEBARMENT OF BIDDER FOR A PERIOD OF 1 YEAR/ Dt.03.05.2024.
