Dear Sir,

The above mentioned work was awarded to you vide above mentioned contract. Without any reasonable cause or valid reason, you had defaulted in providing the vehicle deployed at POOL of Civil Department of Talcher Area from 25.02.2024 to till date. In this regard a notice vide no.569 dtd.12.03.2024 was issued to you i.e. **DEBASIS SAHOO** in which it was advised to provide the vehicle within 15(fifteen) calendar days from the date of issue of the said notice failing which penal action as per terms and conditions of GEM portal mentioned in notice shall be taken against your firm. But you neither replied to the notice nor provided the vehicle.

Accordingly incident has been raised on GeM portal vide no.1871874. Letter regarding Rescission of GEM contract has already been issued vide above mentioned number. However, since you have availed exemption from EMD being MSE during bid submission, forfeiture of bid security/earnest money is not applicable.



In view of the above, the following penal actions are hereby imposed on you as per Cl.No.8 of SLA, Cl.No.47(c) of Buyer added bid specific ATC, Cl.No.9 of Buyer added bid specific ATC of GEM contract:

- i. The PSD amount of Rs.47,000.00 is forfeited.
- ii. An additional penalty of Rs.41,606.00 (Rupees Forty One Thousand Six Hundred Six) is imposed on you which is to be deducted from the bills of **DEBASIS SAHOO** as and when you raise the bills.
- iii. Debarment of **DEBASIS SAHOO** from participating in future tenders of MCL for a period of one year from the date of issue of this letter vide FD No.FD/MCL/SBP/2024-25/REV/D-64/APPROVAL FOR DEBARMENT OF BIDDER FOR A PERIOD OF 1 YEAR/Dt.26.04.2024
