**Sub: Cancellation of contract & Debarment from participating in future tenders of MCL for a period of one year.**

Dear Sir,

With reference to the above GeM contract, you were awarded the service contract "Hiring of One (01) No. of Scorpio or equivalent Diesel Jeep with AC fitted having seating capacity 7(6+1) for a period of Two years (i.e.682 Days) @ 12Hrs/day, maximum run of 2800 Km/Month (100Km/day) engagement at Pool of GM, Talcher Area." But you neither submitted PSD nor commenced the work as per schedule mentioned in GeM contract. In this regard before taking penal action a show cause notice was issued to you in which it was instructed to submit reply and you submitted your reply in which you had asked for another 10 days to submit PSD and to deploy the vehicle ERTIGA instead of SCORPIO. But in your offered specification you had mentioned to provide MAHINDRA SCORPIO at the time of bidding and reply of your letter has been communicated to you.

As per Point No.8 of Cl.No.2.11 under Buyer added Bid specific ATC,

Quote:

**"After award of contract, Successful Bidder can upload scanned copy of the DD/FDR/PBG in place of PBG and has to ensure delivery of hard copy to the original DD/FDR/PBG to the Buyer within 15 days of award of contract. In case the successful bidder fails to submit the Performance Security within the stipulated time then the award of work shall be cancelled with forfeiture of the bid security / earnest money. Additionally, the company shall debar such defaulting contractor from participating in future tenders of MCL for a minimum period of one year from the date of issue of such letter."**

Hence you had to submit the performance security in the form of DD/FDR/PBG within 15 days of award of contract i.e. latest by 12.09.2023. But you didn't submit the PSD. Accordingly incident will be raised on GeM portal. However, since you have availed exemption from EMD being MSE during bid submission, forfeiture of bid security/earnest money is not applicable.


