Sub: - Banning of Business

- Ref : 1. CIL's open e-tender tender no. CIL/C2D/Printing/R-63/311 dated 26/03/2018 for the job of "Printing of Annual Report & Accounts for the year 2017-18
2. Your offer no. CIL/C2D/PRINTING/R-63/311 dated 26.03.2018 submitted vide Bid ID 292995 through CIL's e-procurement portal
3. CIL's Show Cause Notice Cum Suspension vide Notice No. CIL/C2D/Printing /R-63/1123 dated 09.01.2019
4. Your letter no. NIL dated 27.01.2019
5. CIL's Show Cause Notice Cum Suspension vide Final Notice No. CIL/C2D/Printing /R-63/1286 dated 22.02.2019
6. Your letter no. NIL dated 01.03.2019
- a. Coal India Limited had issued an open e-tender for the job of "Printing of Annual Report & Accounts for the year 2017-18 as referred at sl no.1, above. Against this tender, you had submitted you offer vide Bid ID 292995 through CIL's e-procurement portal.
- b. In your offer dated 26.03.2018 referred at sl no. 2 above, it was found that you have confirmed of not being banned in Commercial Parameter Sheet & submitted self-declaration that you have not been banned or de-listed by any Government or Quasi-Government agencies or PSUs including CIL and Subsidiaries. However, it was noticed that your name is appearing in the list of banned firm/ vendor in the official website of M/s NHPC Ltd. (Miniratna Company) and M/s Energy Efficiency Services Limited (a JV of PSU's under Ministry of Power). On clarification you have submitted that you have been banned in NHPC Ltd.
- c. Your above act amounts willful suppression of fact with respect to your ban in NHPC, furnishing wrong information and use of unfair means in the CIL's open e-tender which amounts to violation of NIT Clause no. 13, "Submission of Forged/Tempered Documents" of Instruction to Bidders and Coal India Purchase Manual Clause no 4.7.7, "Banning of Business".
