1. General Terms and Conditions-

- 1.1 This contract is governed by the [General Terms and Conditions](#), conditions stipulated to this Product/Service as provided in the Marketplace.
1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable

2. Buyer Added Bid Specific Terms and Conditions-

2.1 Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2.2 Scope of Supply:

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2.3 Certificates:

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

2.4 Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. [Click here to view the file](#).

2.5 Buyer Added Bid Specific ATC:

Buyer Added text based ATC clauses

1. Experience Criteria: The Bidder or its OEM (themselves or through reseller(s)) should have regularly, manufactured and supplied same or similar Products to any Private / Central / State Govt Organization / PSU / Public Listed Company for 1 year before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity. Contract copies should be at least 01 year older and it should not be older than 05 years as on bid opening date.

2. All bidders to submit self certificate in the given format in support of Experience Criteria: "The items covered in the contact copies enclosed with our offer have been fully executed and have performed satisfactorily as per the provisions of respective contract and all the complaints/claims lodged by the purchaser, if any, have been attended to and no complaints/ claims are pending."

3. Definition of similar Product: Steel cord conveyor belting having belt width and belt strength greater or equal to tendered item will be considered as similar product.

4. Warranty: Warranty shall remain valid for eighteen (18) months from the date of receipt and acceptance of material at consignee's end or twelve (12) months from the date of its use/fitment/commissioning, whichever is earlier. All cases of warranty replacement of failed item will be decided on the basis of joint inspection of the failed item held between the user and the manufacturer's representative. The supplier will have to depute representative for joint inspection within 10 days of intimation of warranty failure. In case if he fails to come for joint inspection within 10 days of intimation, the warranty claim raised by the consignee shall be treated as final and supplier will be liable to make warranty replacement of the failed item.

5. Documents to be submitted by all bidders during bid submission: (a) Bid specific authorization containing bid number from Manufacturer of offered steel cord conveyor belts.

(b) Documents related to Micro-Small enterprise status of firm for tendered item.

(c) Documents in support of Experience Criteria (Contact copies & Self certificate).

(d) Copy of self attested Technical Parameter Sheet / Buyer Specification Document of Steel cord Conveyor Belts.

(e) Filled up copy of PROFORMA FOR EQUIPMENT AND QUALITY CONTROL for MSEs and Start-ups, if availing relaxation in experience criteria.

6. Documents to be submitted with the supply of belting: Test report of steel cord conveyor belts as per IS 15143:2002.

7. Product/Product delivery should comply with, ensuring the quality of service, protection of the environment and health & safety during and after their activities, as per Company/Govt. norms.

8. The clarification/shortfall documents if any will be sought only once. The clarification document submitted in the representation after technical evaluation will not be accepted.

9. Mahanadi Coalfields Limited (MCL) has onboarded the TReDS platform through Receivables Exchange of India Limited (RXIL). TReDS is an online discounting platform primarily meant for MSME vendor to get their trade receivables financed through auction mechanism where multiple financiers can participate in a very transparent manner. 10. The successful L-1 bidder shall submit Security deposit for 3% for a period of 7 months (i.e., 5 months delivery period + 2 months additional) which is opted in place of e-PBG, and 10% PBG to be submitted which shall be valid up to 18 months from the date of receipt and acceptance of materials by the consignee, which has been incorporated in the bid in Buyer uploaded ATC document.

11. Pre-dispatch inspection at Seller premises : Before dispatch, the goods will be inspected by our Inspection Agency (CMPDIL) at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. Inspection charges as applicable (present rate @ 1% + applicable GST of order value) shall be paid to CMPDIL by the seller and the same will be included in the unit price. Seller will provide all facilities to carry out necessary Tests as required. Seller shall pay the Predispatch inspection charge through e-mode through State Bank Collect. Visit CMPDI site www.cmpdi.co.in & click on the link of State Bank Collect to pay Inspection Fee & follow the steps therein. Seller shall notify CMPDI through e-mail about readiness of goods for predispatch inspection, with a copy to the Buyer. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/Consignee or its Nominated External Inspection Agency prior to the goods' shipment.

12. The seller has to upload all relevant documents (like Guarantee/Warranty certificate, Delivery Challan, E-waybill, Test report, any other document mentioned in the contract which ever is applicable) in the GeM portal while generating Invoice.

13. The clarification/representation submitted against the BID document through any mode other than GeM portal will not be considered.
