A: Technical Terms and Conditions

1. **All Bidders are required to submit following documents during bid submission for eligibility and experience criteria.**
 - i. **Documents related to Micro- Small manufacturing enterprise (MSE) status for tendered items.**
 - ii. **BIS license for ISI marking as per IS 2713 on offered Tubular Poles**
2. **Documents to be submitted by supplier at the time of supply of material:-**
 - i. **Test report of Tubular Poles as per IS 2713.**
3. **Inspection: - Final inspection of the materials shall be carried out at the consignee's end by staff officer (E&M) of the respective area or his authorized representative. No pre-dispatch inspection required.**
4. **Warranty: Warranty shall remain valid for eighteen (18) months from the date of receipt and acceptance of material at consignee's end or twelve (12) months from the date of its use/fitment/commissioning, whichever is earlier or Warranty shall remain valid as per the offered product sheet, if higher warranty period than above is offered by seller. All cases of warranty replacement of failed item will be decided on the basis of joint inspection of the failed item held between the user and the manufacturer's representative. The supplier will have to depute representative for joint inspection within 10 days of intimation of warranty failure. In case if he fails to come for joint inspection within 10 days of intimation, the warranty claim raised by the consignee shall be treated as final and supplier will be liable to make warranty replacement of the failed item.**
