Vide employment notice 600 Dt-15/12/2022, the candidates who have qualified the Computer Based Test (CBT) held on 21/Feb/2023, are hereby called for document verification PROVISIONALLY in the order of merit under UR category only and their names are appended at page-02.

The candidates are hereby advised to report on the date, time and at the address mentioned in the schedule accordingly. The candidates must go through the said advertisement and they must bring the following documents in support of the declaration made in the online application. The candidates are further advised to take note of the following terms & conditions:-

- 1) Calling for document verification does not guarantee or confer any right for Offer of Employment by MCL.
- 2) You must bring the following **ORIGINAL** certificates/testimonials etc. along with the **self-attested** photocopy/xerox of the same (**02 sets**).
 - a) Valid Survey Certificate of Competency (**Un-Restricted only**) granted by Directorate General of Mines Safety (DGMS) as per Coal Mines Regulation 2017 for working in both **Open Cast (OC) & Under Ground (UG) Mines.**
 - b) Matriculation or equivalent Examination from any recognized Board of Examination.
 - c) Senior Secondary school examination or intermediate examination (10+2) or equivalent Examination from any recognized Board of Examination. **OR** Diploma in Mining/Mine surveying Engineering of 03 years duration or Degree in Mining/Mine Surveying Engineering or other equivalent qualifications approved in that behalf by the Central Government from any recognized Institute.
 - d) **No Objection Certificate (NOC)** from your present employer, if you are working in a Govt./Semi Govt./PSU.
 - e) Valid Aadhaar Card (preferably)/ Driving License/ Voter ID etc.
- 3) The statutory certificate i.e. Survey Certificate of Competency is to be submitted during document verification and it will be retained by MCL for subsequent verification from the issuing authority. Only after verification from the issuing authority the competency certificate will be returned to the candidate.
- 4) All the documents must be valid as on the cut-off date i.e.,**23/01/2023** as mentioned in the said advertisement.
- 5) The candidates will be intimated through email/sms as provided in their application and also notified in MCL website. The Management will not be responsible for whatsoever reason for non-receipt/delayed receipt of intimation for document verification etc.
- 6) The candidate who fails to attend the document verification on the said due time & date, it will be presumed that the candidate is not interested in document verification of Surveyor T&S Gr-B and the management will proceed accordingly without any further reference to the candidate.
