After inclusion of GST @18% in the quoted value, the value comes to Rs.24,07,82,870.40 (Rupees Twenty-four Crore Seven Lakh Eighty-two Thousand Eight Hundred Seventy and Paise Forty only).

The annualized value of the Contract amount (Excluding GST) is Rs.6,80,17,760/-, with the period of contract of 1095 days.
